A. Description

International Conversion Plans are offered to enable existing Comcast local customers with non-Comcast International Calling Plans to migrate to a comparable Comcast International Calling Plan. Plan descriptions are set forth in C., following.

B. Terms and Conditions

“You” and “Your” mean current or potential customers of Comcast Service.

“Company” means Comcast Phone, LLC and any subsidiaries or affiliates providing service under this Service Guide.

1. To participate in this plan, you must:

- Currently have, or choose Comcast as your Primary Long Distance Carrier.
- Enroll in this plan by doing one of the following:
 - Complete and return a written subscription form to Comcast.
 - Call a designated Comcast 800 number to subscribe.
 - Subscribe during a marketing contact with Comcast.

2. This plan includes the following types of calls:

- Direct dialed station international calls that are:
 - made from your home,
 - billed to your main telephone account, and made without using an operator or an automated call processing system.
- Direct dialed station international calls from the US Mainland to foreign countries or areas where service is available.
- All other types of calls are rated at basic rates unless you are enrolled in another plan that covers these other types of calls.

B. Terms and Conditions (Cont'd)

3. Comcast will provide the benefits of this plan until one or more of the following events occur:
 - The Company changes and/or discontinues this plan.
 - The Company is notified that you no longer subscribe to Comcast as your Primary Long Distance Carrier. Discontinuance will be effective as of the date the Company's records show that you no longer subscribe to Comcast.
 - You notify the Company that you want to withdraw from this plan.
 - International Conversion Plans are offered to existing customers on a grandfathered basis only. Modifications of existing service arrangements/configurations may result in the loss of grandfathered status and require migration to existing (available) calling plans.
4. You can enroll in only one international pricing plan for Comcast direct dialed station international calls for each main telephone account unless the Company notes otherwise.
5. The Company will bill for this plan based on the following:
 - The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).
 - If your main telephone account has multiple lines associated with it, your Monthly Recurring Charges and Usage Charges for that account will be billed as if you have a single line account even though you have multiple lines.
 - If applicable, the following conditions apply to the Monthly Recurring Charge (MRC):
 - Billed in advance (you may have two MRCs charged to your account in the first billing month, which apply to the month you enrolled as well as the next month).
 - Applied whether or not you make any calls.
 - Adjusted when the billing period covers less than or more than a full month (for this purpose, each month is considered to have 30 days).
 - Billing Availability:
 - The Company will provide this plan in locations where billing and technical resources are available.
 - Usage rates for this plan apply to calls placed during your entire billing month in effect at the time you subscribe.
