A. Description

Service is discontinued effective December 17, 2008 in all locations.

This plan offers you a combination of services that include one local access line, unlimited local calling, that the customer may use for local toll, intrastate or interstate calling, and a selection of custom calling features for a monthly recurring charge. The service may be ordered on the Primary line and/or on additional lines.

B. Terms and Conditions

“You” and “Your” mean callers, current or potential customers who use Comcast service.

“Company” means Comcast Phone of Michigan, LLC and its subsidiary and affiliates authorized to provide service on the Company’s behalf.

1. To participate in this service, you must:

- Choose the Company (or a Company affiliate) as their Primary Carrier for all of the following:
 - Local Exchange Carrier,
 - in-state toll Carrier, and
 - interstate Long Distance Carrier.
- Customers can enroll in this offer by calling a Company-designated 800 number or during a marketing contact with the Company.

2. This plan includes the following:

- The Comcast Connections Any Distance Plan provides the residential Customer with one access line, unlimited local calling, Caller ID, Call Waiting, Caller ID with Call Waiting, Call Return, LD Alert, and unlimited direct-dialed domestic usage. Additional access lines and custom calling features (excluding Call Forwarding Remote Access) may be ordered by the Customer on an a la carte basis at an additional charge
- Due to the bulk nature of the Any Distance Plan usage, call detail is not automatically provided on the monthly billing statement. Upon Customer request, such detail will be provided under separate cover.

B. Terms and Conditions

2. This plan includes the following (Cont'd):

- Usage credits are applied per line and are not transferable and may not be accumulated from one month to another. Unused minutes in any month revert to the Company.
- This service is offered subject to the availability of existing facilities and systems. Service is limited to residential voice applications and is not intended for commercial, data or internet usage. Use of service is limited to the customer, members of the customer's household and occasional guests. Participation may be terminated for customers who utilize service in a manner or for a purpose other than those described herein. Promotion may not be combined with other promotions or offers.

C. Rates and Charges

- A Monthly Recurring Charge as specified in the appropriate state tariff applies. The monthly rate applies for each account[1] on which the plan is ordered.

[1] **Grandfathered regulation:** for Customers who are subscribed to Comcast Connections Any Distance on or before March 31, 2004, and do not initiate any change to their account, the offer will be applied at the line level and all usage will be aggregated at the line level. Monthly rate applies for each line on which the discount is ordered.
