

## **Global Satellite Long Distance**

### **A. Description**

Global Satellite Long Distance service allows customers to originate calls to satellite phone subscribers at a fixed, per-minute rate. All minutes terminated to a satellite phone number are billed at a uniform rate regardless of the physical location of the called party.

### **B. Terms and Conditions**

“You” and “Your” mean current or potential customers.

“Company” means Comcast Phone of Northern Virginia, Inc. and any affiliates authorized to provide service on the Company’s behalf. (D)

1. To utilize this service, you must:
  - Currently have, or choose the Company as your Primary Long Distance Carrier.
2. This service includes the following types of calls:
  - Direct dialed global satellite calls that are:
    - made from your home,
    - billed to your main telephone account, and made without using an operator or an automated call processing system. (Operator Services are not currently available in conjunction with global satellite calling.)
3. The Company will provide this service until one or more of the following events occur:
  - The Company changes and/or discontinues this service.
  - The Company is notified that you no longer subscribe to the Company as your Primary Long Distance Carrier. Discontinuance will be effective as of the date the Company’s records show that you no longer subscribe.

### B. Terms and Conditions (Cont'd)

4. The Company will bill for this service based on the following:
  - The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).
  - If your main telephone account has multiple lines associated with it, your Usage Charges for that account will be billed as if you have a single line account even though you have multiple lines.
  - Billing Availability: Global Satellite calling availability is limited to locations where billing and technical resources are available.

### C. Rates and Charges

1. Local, State and/or Federal taxes may apply. The Company reserves the right to pass-on taxes or fees imposed on the Company by any taxing authority.
2. Charges are based upon usage only; monthly recurring charges do not apply.
