A. Description

This plan offers residential subscribers to place a direct dialed station international call from their main billed residence account.

B. Terms and Conditions

You” and “Your” mean current or potential customers.

1. To participate in this plan, you must:
 - Currently have, or choose the Company as your Primary Long Distance Carrier and not select another international direct dialed station plan.
2. This plan includes the following types of calls:
 - Direct dialed station international calls that are:
 - made from your home,
 - billed to your main telephone account, and made without using an operator or an automated call processing system.
 - Countries/areas where service is available are indicated in the rate tables.
3. The Company will provide the benefits of this plan until one or more of the following events occur:
 - The Company changes and/or discontinues this plan.
 - The Company is notified that you no longer subscribe to the Company as your Primary Long Distance Carrier. Discontinuance will be effective as of the date the Company’s records show that you no longer subscribe.
 - You select another international direct dialed station plan.

4. You can enroll in only one international pricing plan for direct dialed station international calls for each main telephone account unless the Company notes otherwise.
5. The Company will bill for this plan based on the following:
 - The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).
 - Usage rates are per minute, per country.
 - Billing Availability:
 - The Company will provide this plan in locations where billing and technical resources are available.

1. Local, State and/or Federal taxes may apply. The Company reserves the right to pass on taxes or fees imposed on the Company by any taxing authority.
2. Service Charges
 - A Monthly Recurring Charge applies to each subscription.
