1. APPLICATION OF TARIFF

1.1. GENERAL

This Tariff applies to the furnishing of Comcast Telecommunications Service, defined herein, by COMCAST PHONE OF TEXAS, LLC (hereinafter referred to as the "Company" or "Comcast" within the state of Texas. Comcast Telecommunications Service is furnished for the use of end users in placing and/or receiving local telephone calls within a Local Calling Area, or in placing intrastate calls within the state of Texas. Services, features, and functions will be provided where facilities, including but not limited to billing and technical capabilities, are available.

The provision of Comcast Telecommunications Service is subject to existing regulations and terms and conditions specified in this Tariff and the Company's Service Guides, and may be revised, added to, or supplemented by superseding issues.

Comcast reserves the right to offer its Customers a variety of competitive services as deemed appropriate by the Company.

In areas in which it offers service, the Company provides service without discriminating based on race, nationality, color, religion, gender, martial status, income level, source of income, and without unreasonably discriminating on the basis of geographic location.

1.2. TARIFF REVISION SYMBOLS

Revisions to this Tariff are coded through the use of symbols. These symbols appear in the right hand margin of the page. The symbols and their meanings are as follows:

- (C) - Change in regulation
- (D) - Discontinued rate, regulation or text
- (E) - Correction of an error made in a revision
- (I) - Increase in rate
- (M) - Move of text but no change in text, rate or regulation
- (N) - New rate, regulation or text
- (R) - Reduction in rate
- (T) - Change in text but no change in rate or regulation

1.3. DEFINITIONS

Automatic Location Identification (ALI)

Automatic Location Identification (ALI) is an E911 feature that provides the name or address or both associated with the calling party's telephone number (identified by ANI as defined below) to the PSAP for display. Additional telephones with the same number as the calling party's (e.g., secondary locations, off-premise extensions) are generally identified with the address of the telephone number at the main location.

Automatic Number Identification (ANI)

Automatic Number Identification (ANI) provides for the telephone number of the calling party to be forwarded to the PSAP.

Business Service (Commercial)

Service is classified and charged for as Business Service where the use is primarily or substantially of a business, professional, institutional or occupational nature, or where a business directory listing is furnished.

Residential Service (Consumer)

Residential Service denotes service provided when the main station is located in a private residence or a residential room or apartment of a building or any type. All listings of the service are in the names of individuals, without a business designation.

Comcast Telecommunications Service

Comcast Telecommunications Service may provide both Comcast Local Service and intrastate calling provided in conjunction with Comcast Local Service, at rates specified in this tariff.

Comcast Local Service

Comcast Local Service provides the Customer with an access line and usage within a Local Calling Area for the transmission of two-way interactive switched voice or data communications.

Customer

The person or legal entity that subscribes to Service under this Tariff and is responsible for payment of charges for Services furnished to that Customer.

1.3. DEFINITIONS (CONT'D)

Customer Premises

The Customer premises is all space in the same building occupied by a Customer and all space occupied by the same Customer in different buildings on contiguous property.

Emergency Service Number (ESN)

Emergency Service Number (ESN) is a Selective Routing (SR) code assigned to each telephone number in an exchange where SR is provided to route E911 calls to an appropriate PSAP. The ESN defines the set of emergency services (e.g. police, fire, PSAP and medical) within a particular serving area. An ESN is associated with a primary possibly one or more secondary PSAPs.

Exchange Area

An exchange area is a geographical area served by a Rate Center. The Company concurs with the Southwestern Bell Telephone Company and GTE Southwest, Inc. areas and exchange maps that are on file for the state of Texas where the Company operates as a Local Exchange Carrier.

Local Calling Area

The area in which a Customer of Comcast Local Service may complete calls without incurring long distance charges.

Local Serving Area

The area in which the Company has the capability to provide Comcast Telecommunications Service.

“P.U.C.” or “Commission”

The Texas Public Utility Commission
