A. Description

Carefree Minutes[®] Mexico 300 service allows the completion of 300 minutes of customer-originated calls to landline phones in Mexico for a fixed monthly rate. This plan also gives unlimited discounted per minute rates for mobile calls to Mexico.

B. Terms and Conditions

"You" and "Your" mean current or potential customers, visitors, guests and any other authorized user (or users who may be reasonably assumed to be authorized) of the customer's Digital Voice Service.

"Company" means Comcast and any subsidiaries or affiliates providing service under this Service Guide.

- 1. To utilize this service, you must:
 - Subscribe to residential Comcast Digital Voice Service, and
 - Currently have, or choose the Company as your Primary Long Distance Carrier.
- 2. This service includes the following types of calls:
 - Direct dialed calls that are:
 - made from your home,
 - billed to your main telephone account, and made without using an operator or an automated call processing system, and
 - placed to a landline phone number.
 - In addition, any mobile calls terminating in Mexico.

This plan does include both landline and mobile terminating calls to Mexico. The landline calls are included in the 300 minute Block of Time (BOT) and the mobile terminating calls to Mexico are at the preferred/discounted rate of \$0.10 per minute.

- 3. The Company will provide this service until one or more of the following events occur:
 - The Company changes and/or discontinues this service.
 - The Company is notified that you no longer subscribe to the Company as your Primary Long Distance Carrier. Discontinuance will be effective as of the date the Company's records show that you no longer subscribe.

B. Terms and Conditions (Cont'd)

- 4. The Company will bill for this service based on the following:
 - The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 25-second call will be billed as a one-minute call). The same rule applies as for domestic voice in regards to calls that are less than 2 seconds in length. These call will not be treated as an incomplete call.
 - Call begins when the call is answered by the called party or an automated answering device (such as an answering machine or fax machine); it ends when one of the parties disconnects the call. Some providers charge for a completed call when the called party's line rings or after a certain number of rings. If such a provider charges Comcast, its affiliates, or suppliers on that basis, Comcast will charge for a completed call.
 - Subscription is limited to one per account. Minutes included in the plan are available to any line on the account. Unused minutes revert to the Company.
 - Availability: Carefree Minutes[®] Mexico 300 subscription availability is limited to locations where billing and technical resources are available. Service may not be offered in all areas,

C. Rates and Charges

- 1. All requirements as outlined in the Comcast Digital Voice Subscriber Agreement apply to this service also. If the customer discontinues Comcast Digital Voice Service, the customer will no longer qualify for this plan.
- 2. Landline terminating calls to Mexico that eclipse the 300 minute maximum included in this service plan within a bill cycle will be billed at the standard landline rates as listed in the International Pricing List. Mobile terminating calls to Mexico have no minute allocation and will be billed at the discounted rate as specified in the plan.
- 3. Local, State and/or Federal taxes may apply in addition to the rate listed below. The Company reserves the right to pass on taxes or fees imposed on the Company by any taxing authority.
